RESOLUTION - 2013 - 002

Resolution to Borrow Money for Road Improvement Projects

WHEREAS, the Town Board has identified several town road improvement projects,

WHEREAS, a Special Town Meeting of Electors on October 29, 2012 approved exceeding the allowable highway expenditures pursuant to sec. 82.03(2) Wis. Stat.,

WHEREAS, it is necessary to borrow money by promissory note to fund the town road improvements and to repay an existing loan (approximate balance of \$433,400) in an amount not to exceed \$750,000 pursuant to sec. 67.12(12) Wis. Stat.,

WHEREAS, a direct, annual, irrepealable tax will be required to be levied for a period of 10 years to pay off the principal and interest on the note, and

WHEREAS, a debt service fund must be established pursuant to sec. 67.11 Wis. Stat.

NOW, THEREFORE BE IT RESOLVED, the Town of Wheatland Town Board of Supervisors does approve the borrowing by promissory note of an amount not to exceed \$750,000 to fund town road improvement projects and to repay an existing loan (approximate balance of \$433,400), does impose a direct, annual, irrepealable tax for a period of 10 years to pay the principal and interest on the promissory note pursuant to sec. 67.12(12) Wis. Stat. and does establish a debt service fund pursuant to sec. 67.11 Wis. Stat.
