

## **FEBRUARY 22, 2010 WHEATLAND TOWN BOARD MEETING**

Meeting was called to order by Chairman Glembocki at 6:30 p.m. on Monday, February 22, 2010 at the Town Hall in New Munster and opened with the *Pledge of Allegiance*.

Town Board members present – Chairman William Glembocki and Supervisors Andrew Lois and Robert Herda. Others present: Clerk Sheila Siegler, Constable Bob Haas, Jack Bobula, Bill Heeg and Jim Mirek. Jacob Castillo and Ron Eckert, prospective 2010 water patrol officers were also in attendance.

Notices were posted in five public areas, the town website and the *Kenosha News* and *Westosha Report* were notified. Individuals who have requested meeting notices by e-mail were also sent agendas as required by state law.

Minutes of the January 25, 2010 and February 8, 2010 Town Board Meetings were motioned for approval by Robert Herda, second by Andrew Lois. Motion carried.

- **Approve Water Patrol Officers for 2010 patrol of Lilly Lake**

Jacob Castillo, a December 2009 graduate of the police academy, currently works for the Town of Norway Police Dept. and served as a water patrol officer on Wind Lake and Lake Waubesa.

Ron Eckert has been a police officer for 15 years, the last 12 with the Kenosha Co. Sheriff's Dept. where he also worked on the Kenosha County Sheriff's Dept. Marine Unit for the last six years.

They would split the hours between themselves for weekend work. Board agreed to reimburse each of them for a bumper hitch for their vehicles so they can trailer the Yamaha wave runner to Lilly Lake. Castillo indicated he was able to attend the required DNR water patrol training class April 7<sup>th</sup> in Rothchild.

Chairman noted the board was looking for more patrol hours on the lake than 2009. The two officers indicated they will be able to provide more hours.

Andrew Lois moved to approve the appointment of Jacob Castillo and Ron Eckert as the 2010 water patrol officers for Lilly Lake. Robert Herda seconded. Motion carried.
