

**Town of Wheatland, Kenosha County, Wisconsin
Resolution No. 2019 -- 001**

Part A. - Relating to 2018 Budget Amendment

WHEREAS, the Town of Wheatland General Fund Budget was previously approved on November 6, 2017, and

WHEREAS, during 2018 the Town of Wheatland entered into an Intergovernmental Agreement with the Tri-County Fire & Rescue Training Association, Inc. for the purpose of the Construction and Use of a Training Facility for Fire Fighters and Other First Responders with a 2018 expense of \$10,000, and

WHEREAS, during 2018 the Town of Wheatland approved the purchase of a used 2006 F-250 brush truck and outfitted it as a dual brush and command truck costing \$46,227.40, and

WHEREAS, during 2018 the Town of Wheatland approved a contract with Keller Planners, Architects and Builders for a needs and space assessment for a new firehouse at \$1,500, and

WHEREAS, during 2018 the Town of Wheatland Volunteer Fire Dept. had unanticipated truck repair expenses of approximately \$10,000, and

WHEREAS, during 2018 the Town of Wheatland Volunteer Fire Dept. completed the purchase and installation of the porta-tank system on the 2016 tanker truck at a cost of \$5,525, and

WHEREAS, during 2018 the Town of Wheatland approved the purchase of a used dock and pier for the Water Patrol for \$4,040, and

WHEREAS, these unexpected expenditures resulted in the Public Safety budget appropriation being overspent.

NOW, THEREFORE, BE IT RESOLVED, the Public Safety line item is increased by \$78,200 to offset this expenditure over budget for 2018.

BE IT FURTHER RESOLVED, \$51,752 will be transferred from the fire department restricted truck fund and the remainder \$26,448 from general fund reserves.

Part B - Relating to 2018 Additions to the Restricted Fire Truck Fund

WHEREAS, the Town of Wheatland has historically set aside funds in reserve restricted for the purchase of fire trucks;


WHEREAS the Town of Wheatland sold the used 1968 Chevrolet fire department brush truck in 2018 for \$8,257 and the Town of Wheatland received unallocated funds for fire service in the amount of \$41,716.

THEREFORE BE IT RESOLVED, funds in the general fund account will be transferred to the town restricted fire truck fund account totaling \$49,973.


