

OCTOBER 19, 2020 WHEATLAND TOWN BOARD MEETING

Meeting was called to order by Chairman William Glembocki at 6:00 p.m. Monday, October 19, 2020 at the Town Hall in New Munster and opened with the Pledge of Allegiance. Town Board members present: Supervisor Andrew Lois and Kelly Wilson. Others present: Clerk Sheila Siegler, Constable Robert Santelli, Robert Tobias, Marc Kaiser and *West of the I* reporter Darren Hillock.

Notices were posted in three public areas (Town Hall, Transfer Station and Wheatland Center School) and the Town website. The Kenosha News and Westosha Report were notified. Individuals who have requested meeting notices by e-mail were sent agendas as required by state law.

Report –

A. Fire Dept. – none (Chief busy with Corned Beef & Cabbage fundraiser)

B. Public Safety Report – Constable Santelli reported the squad was serviced today. Mileage is currently just under 24,000. He spoke to the parent of the Slades Corners teenager responsible for the road racing, the subject of the complaint from Slades Corners residents at last week's meeting. He also noticed black marks on the pavement in the 376th Ave./31st St. area.

The Vortex range finder should be here soon.

He would like the board to consider signs for Oakwood Shores Park that state “no ATV's in the park.”

Supervisor Andrew Lois asked about the property on 328th Ave. north of STH 50. Constable said he planned to go back there once he could see into the property when the leaves are all off.

C. Work on 2021 budget – set date for budget meeting & special elector meeting to approve levy. The board went over 9-month expenses and receipts and discussed budget amounts. Work will continue after the election.

Chairman Glembocki said he wants to put \$50,000 aside in restricted funds for a future fire truck. Currently there is \$84,510 in the restricted fire dept. equipment fund. He wants the board members to

consider adding \$50,000 for the 2021 budget.

Andrew Lois moved to cancel the November 9 board meeting and instead meet in November on the 16th and 30th, and to schedule a budget workshop at 5 p.m. November 11. Kelly Wilson seconded. Motion carried.

William Glembocki moved to set the hearing for the 2021 budget for November 30, 7 p.m. at the town hall and to call a special town meeting immediately following the budget hearing for the purpose of approving the 2020 tax levy. Kelly Wilson seconded. Motion carried.

Adjournment - William Glembocki moved to adjourn at 7:10 p.m. Kelly Wilson seconded. Motion carried.
