A packed room discussed issues ranging from weed control to lake water levels. AQUATIC PLANT STUDY COMPLETED

Aron & Associates was contracted by the Town of Wheatland in 2008 to conduct an aquatic plant survey and to create an Aquatic Plant Management Plan under a grant awarded by the Wisconsin Department of Natural Resources (WDNR) Lakes program. The completed report can be found at: www.townwheatland.com, then click on “Directory”, then on “Lilly Lake Protection and Rehabilitation”, then on “Reports”.

A total of 15 plant species were found, most being high quality native plants. Two species, curlyleaf pondweed and Eurasian water milfoil, are exotic invasive plants we don’t want in the lake. Recommendations were to manage these two plants before they outcompete the beneficial native plants.

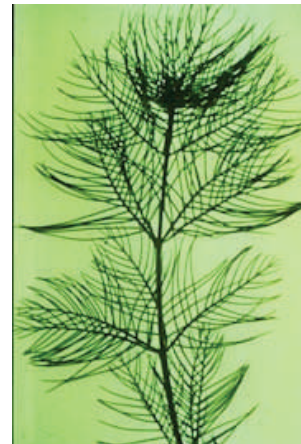
In addition, the swimming beach area was also treated.



As a result of this study, an aquatic plant management committee was formed to address the concerns mentioned in the plan. In both 2009 and 2010, chemical treatments targeted areas of Eurasian water milfoil. In
