- 2. Motion by Brett to purchase six foot bench with donation money from Summerhaven, 2nd by Brian

c.) Oakwood shores park:

1. Discussion around disk golf course feasibility, no action taken

d.) Koch Park:

1. Motion by Steve Peters and 2nd by Paul to skip the portable restroom rental this year.

Report: currently three advertising spaces available on the back of the scoreboard and two on the front.

Still waiting on the rails for the Lilly Lake beach stairs. New Munster park still needs the scorer booth and food stand repaired. Chairman Niederer said he would complete, and also get a price to fix the basketball court light. There is still a problem with vehicles driving through Oakwood Shores and Koch Parks, it was agreed to revisit the topic in February, meanwhile Andrew will contact someone who may be able to drive posts so that posts and chain may be erected like around New Muster Park. A motion was made by Paul DeLuisa to recommend to the town board the installation of maple trees for shade at Lilly Lake Beach in the amount of \$1375.78, to be completed by Peters Landscapes. Second by Andrew Lois.
