

**TOWN OF WHEATLAND  
TOWN BOARD MEETING

**Monday, November 13, 2023 – 6:00 p.m.**

The meeting was called to order by Chairman Brett Butler at 6:00 p.m., Monday November 13, 2023 at the Town Hall and opened with the Pledge of Allegiance. Town Board Members present, Chairman Brett Butler and 2<sup>nd</sup> Supervisor Kelly Wilson and Supervisor Kyle Madsen. Also present: Clerk Deuster, Lou Denko, Tracy Denko, and Wayne Kaddatz.

Meeting notices were posted at the Post Office, Town Hall, Wheatland School, Westosha Report and Kenosha News, emailed to interested parties list.

Meeting was open at 6 pm with the Pledge of Allegiance led by Chairman Butler.

Motion to approve the minutes from the previous meeting on 11-2 was made by Supervisor Madson, seconded by Supervisor Wilson, Motion carried and meeting on 10-23 with noted corrections was made by Supervisor Madsen and seconded by Supervisor Wilson. Motion carried.

Chief Danko reported the fire department is working with mutual response with Randall fire department on all fire calls for the next year to see how it works. There is no formal documentation on this agreement.

The banquet which was the first one in 5 years went well and was well attended.

Chief Danko had a conversation with the project manager of the Hwy 50 work being done. He was told when the crossovers were finished the barrels would be put back in the median until next March or April when the work will restart. Chief Danko is working with Salem Lakes on response if the bridge would become a blockage for vehicles to get through.

Wayne Kaddatz spoke at public comments asking for a street sweeper to sweep the curbs in Slades Corners.

*An agreement with Harm Garwood to move and store any vehicles which would have to be moved with the current ordinance we have. Motion to accept the agreement by Chairman Butler, seconded by Supervisor Wilson. Motion carried.*

The 2024 animal control agreement with Kenosha County Sheriff was approved with a motion from Supervisor Madson, seconded by Supervisor Wilson.

Supervisor Wilson stated she would be working on opening the communication for future state jobs in our area starting with Clement Abongwa from Kenosha County Highways.

Chairman Butler reported the crack sealing is still on line to be done.

Supervisor Madsen reported he is working sign placement for the prohibited air braking, and waiting for the signs to come in for the ATV's.

Supervisor Wilson reported she is working with Tim Popanda from Twin Lakes regarding sharing of a speed trailer, and waiting for Bob to decide on his equipment needs.
