CHAPTER XLIII

SPEED ZONES/STOP SIGNS

Section 43.00. <u>Purposes</u>. The purposes of this chapter are to modify existing speed limits on designated Town roads within the Town of Wheatland pursuant to Section 349.11(3)(c), Wis. Stats., to confirm speed zones previously created by ordinance, and to authorize stop signs at various intersections of and with Town roads.

- Section 43.10. <u>Prohibited Speeds and Zones</u>. No person shall drive a vehicle at a speed in excess of the following limits in the zones herein set forth.
 - A. 35 m.p.h. on 45th Street for a distance of 2,940 feet (approximately .56 miles) east from its intersection with County Trunk Highway W (328th Avenue).
 - B. 35 m.p.h. on 51st/52nd Street beginning at its intersection with State Trunk Highway 83 and continuing west for a distance of .82 miles to its intersection with 352nd Avenue (County Trunk Highway KD).
 - C. 35 m.p.h. on 52nd Street, commencing at its intersection with County Trunk Highway KD (352nd Avenue) and continuing West for a distance of approximately .62 miles to its intersection with 368th Avenue.
 - D. 35 m.p.h. on 368th Avenue from its intersection with State Trunk Highway 50 north to its intersection with 31st Street (Wheatland/Burlington Town line) with the exception of 45 m.p.h. beginning 1.32 mile north of its intersection with State Trunk Highway 50 and continuing north for a distance of 3,900 feet (approximately .74 miles).
 - E. 45 m.p.h. on 376th Avenue from its intersection with State Trunk Highway 50 north to its intersection with 31st Street (Wheatland/Burlington Town line).
 - F. 45 m.p.h. on 392nd Avenue from its intersection with State Trunk Highway 50 north to its intersection with 31st Street (Wheatland/Burlington Town line).

- G. 35 m.p.h. on Geneva Road (60th Street) beginning at its intersection with State Trunk Highway 50 and continuing south and west to its intersection with 341st Avenue.
- H. 35 m.p.h. on Geneva Place beginning at its east dead-end cul-de-sac and continuing west .15 miles to its intersection with Geneva Road (60th Street).
- I. 35 m.p.h. on 396th Avenue beginning at its intersection with 400th Avenue (County Trunk Highway P) and continuing northeast to Geneva Road (60th Street).
- J. 35 m.p.h. on 392nd Avenue beginning at its intersection with State Trunk Highway 50 and continuing south to Geneva Road (60th Street).
- K. 35 m.p.h. on 31st Street beginning at its intersection with 376th Avenue and extending West to 392nd Avenue.
- L. 25 m.p.h. on Geneva Road (60th Street) beginning at its intersection with 341st Avenue and continuing west to its intersection with 347th Avenue.
- M. 35 m.p.h. on Geneva Road (60th Street) beginning at its intersection with 347th Avenue and continuing west to its intersection with 400th Avenue (County Trunk Highway P).
- Section 43.20. <u>Vehicles to Stop at Stop Signs</u>. Except when directed to proceed by a traffic officer or traffic control signal, every operator of a motor vehicle approaching an official stop sign at an intersection shall cause such vehicle to stop before entering the intersection and shall yield the right-of-way to other vehicles which have entered or are approaching the intersection upon a highway or road which is not controlled by an official stop sign or traffic signal. Stops required shall be made at stop signs placed as follows:
 - A. In the northwest corner of the intersection of 75th Street and 312th Avenue for traffic proceeding south on 312th Avenue.
 - B. In the southeast corner of the intersection of 75th Street and 314th Avenue for traffic proceeding north on 314th Avenue.
 - C. In the southwest corner of the intersection of 75th Street and Lilly Lake Road for traffic proceeding east on 75th Street.
 - D. In the northeast corner of the intersection of 76th Street and Lilly Lake Road for traffic proceeding west on 76th Street.

- E. In the southwest corner of the intersection of 76th Street and Lilly Lake Road for traffic proceeding southeast on 76th Street.
- F. In the northeast corner of the intersection of 334th Avenue and Lilly Lake Road for traffic proceeding northwest on Lilly Lake Road.
- G. In the southwest corner of the intersection of 77th Street and Lilly Lake Road for traffic proceeding southeast on 77th Street.
- H. In the southeast corner of the intersection of 80th Street and 336th Avenue for traffic proceeding north on 336th Avenue.
- I. In the southwest corner of the intersection of 80th Street and 336th Avenue for traffic proceeding east on 80th Street.
- J. In the southeast corner of the intersection of 63rd Street and 345th Avenue for traffic proceeding north on 345th Avenue.
- K. In the northeast corner of the intersection of 85th Street and 402nd Avenue for traffic proceeding west on 85th Street.
- L. In the southeast corner of the intersection of 45th Street and Cranberry Court for traffic proceeding north on Cranberry Court.
- M. In the southeast corner of the intersection of 31st Street and 376th Avenue for traffic proceeding north on 376th Avenue.
- N. In the southwest corner of the intersection of 31st Street and 376th Avenue for traffic proceeding east on 31st Street.
- O. In the southeast corner of the intersection of 31st Street and 368th Avenue for traffic proceeding north on 368th Avenue.
- P. In the southwest corner of the intersection of 31st Street and 368th Avenue for traffic proceeding east on 31st Street.
- Q. In the northeast corner of the intersection of 368th Avenue and 52nd Street for traffic proceeding west on 52nd Street.
- R. In the southeast corner of the intersection of 330th Avenue and 73rd Street for traffic proceeding north on 330th Avenue.

- S. In the southeast corner of the intersection of 331st Avenue and 73rd Street for traffic proceeding north on 331st Avenue.
- T. In the southeast corner of the intersection of 332nd Avenue and 73rd Street for traffic proceeding north on 332nd Avenue.
- U. In the northeast corner of the intersection of 57th Street and 368th Avenue for traffic proceeding west on 57th Street.
- V. In the northeast corner of the intersection of 55th Street and 368th Avenue for traffic proceeding west on 55th Street.
- W. In the Southwest corner of the intersection of 368th Avenue and 55th Street for traffic proceeding east on 55th Street.
- X. In the Southeast corner of the intersection of 52nd Street and 363rd Court for traffic proceeding north on 363rd Court.
- Y. In the Southeast corner of the intersection of 52nd Street and 366th Avenue for traffic proceeding north on 366th Avenue.
- Z. In the Northeast corner of the intersection of 376th Avenue and 52nd Street for traffic proceeding West on 52nd Street.
- AA. In the Southeast corner of the intersection of 396th Avenue and 60th Street for traffic proceeding North on 396th Avenue.
- BB. In the Northwest corner of the intersection of 392nd Avenue and 60th Street for traffic proceeding South on 392nd Avenue.
- CC. In the Northwest corner of the intersection of 384th Avenue and 60th Street for traffic proceeding South on 384th Avenue.
- DD. In the Northwest corner of the intersection of 376th Avenue and Geneva Road for traffic proceeding South on 376th Avenue.
- EE. In the Southeast corner of the intersection of 373rd Avenue and Geneva Road for traffic proceeding North on 373rd Avenue.
- FF. In the Southeast corner of the intersection of 366th Court and Geneva Road for traffic traveling North on 366th Court.

- GG. In the Southeast corner of the intersection of 351st Avenue and Geneva Road for traffic proceeding North on 351st Avenue.
- HH. In the Southeast corner of the intersection of 347th Avenue and Geneva Road for traffic proceeding North on 347th Avenue.
- II. In the Northwest corner of the intersection of 346th Avenue and Geneva Road for traffic proceeding South on 346th Avenue.
- JJ. In the Southeast corner of the intersection of 345th Avenue and 63rd St. for traffic proceeding North on 345th Avenue.
- KK. In the Northwest corner of the intersection of 344th Avenue and Geneva Road for traffic proceeding South on 344th Avenue.
- LL. In the Southeast corner of the intersection of 344th Avenue and Geneva Road for traffic proceeding North on 344th Avenue.
- MM. In the Southeast corner of the intersection of 341st Avenue and Geneva Road for traffic proceeding North on 341st Avenue.
- NN. In the Northeast corner of the intersection of Geneva Road and Geneva Place for traffic proceeding West on Geneva Place.
- OO. In the Southeast corner of the intersection of 392nd Avenue and 31st Street for traffic proceeding North on 392nd Avenue.
- PP. In the Southwest corner of the intersection of 45th Street and 348th Avenue for traffic proceeding East on 45th Street.
