Presentation and review of 2026 Town Budget:

Review of Receipts:

Utility aid will be received this year from the Solar Farm off of Highway 50 and the Substation for the 2024 year.

Review of Disbursements:

Overview of raises. No one at this time is eligible for a raise.

Added line 31 for Deputy Clerk just to see an amount paid out.

Water patrol had a problem with the motor and it had to be replaced during this year. Our municipal Constable was out for 3 months of this year so that contributes to the reduction in disbursements this year.

Fire Safety had a problem with the original budget as it should have been higher, from \$93,000 to \$98,500, where it should be. Other bills are still coming in for vehicles and that should be added to disbursements.

Roads: 396th, Cranberry Knolls, and 376th (1/3 completed).

Health and Human Services for cemeteries. Clerk is looking into working with someone to clean and fix some of the Baptist cemetery.

Parks does not have any projects planned so the budget stays as is.

Debt is now paid off for the road loan.
